Directions

from Boston's Logan Airport:

1. On leaving Boston's Logan Airport bear to the right, taking Route 1A North for 3 miles.
2. At Bell Circle in Revere, go straight through onto Route 60 West for 2 miles.
3. At the rotary where Route 60 intersects Route 1, take Route 1 North.
4. Stay on Route 1 North for about 6.6 miles until you reach the junction of Route 1 and Route 128. Sign says, "95S and 128N/S Burlington/Gloucester" Take Route 128 North. Take Route 128 North to Exit 22 W. At bottom of exit ramp, take a right onto Route 62.

Take your first right onto State Road, bear right at fork onto Conant Street. Follow Conant Street past the Cherry Hill Creamery on left and take a left onto Cherry Hill Drive.

Axcelis Technologies is the first building on your right at 108 Cherry Hill Drive.

From the South, Take Route 128N to Exit 22W (this is Route 62 towards Middleton). At the light, take a right and go under the 128 overpass. Next take a right at the sign that says To 128. Don't get back on 128. The street then curves to the left and forks. Take the right hand fork. This puts you on Conant Street Take the second entrance to Cherry Hill Park on the left We are the first building on the right Go around the building to the left Visitor parking is 3/4 around the building from the Cherry Hill entrance.

From the North, Take 128S to Conant Street Exit Take a right onto Conant St. off the Ramp Take the second entrance to Cherry Hill Park on the left We are the first building on the right Go around the building to the left Visitor parking is 3/4 around the building from the Cherry Hill entrance.
