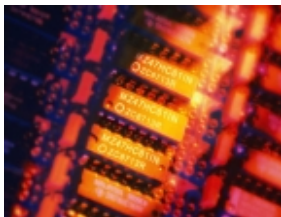

From Boston's Logan Airport:

- On leaving Boston's Logan Airport bear to the right, taking Route 1A North for 3 miles.
- At Bell Circle in Revere, go straight through onto Route 60 West for 2 miles.
- At the rotary where Route 60 intersects Route 1, take Route 1 North.
- Stay on Route 1 North for about 6.6 miles until you reach the junction of Route 1 and Route 128. Sign says, "95S and 128N/S Burlington/Gloucester." Take Route 128 North.
- Take Route 128 North to Exit 22 W. At bottom of exit ramp, take a right onto Route 62.
- Take your first right onto State Road, bear right at fork onto Conant Street.
- Follow Conant Street past the Cherry Hill Creamery on left and take a left onto Cherry Hill Drive.



- Axcelis Technologies is the first building on your right at 108 Cherry Hill Drive.

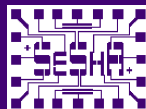
